It is vital to establish competence requirements of the business prior to review of staff skills and experience. The competence criteria will be unique for each firm.

The competence criteria may be further enhanced by a Person Specification for each job designation.

COMPETENCE REVIEW

The competence criteria established will be used to review each technical member of staff on an initial basis. A gaps analysis is then developed to fill any areas of concern found.

Competence is then reviewed on an ongoing basis against the competence criteria which is maintained to include any changes to standards, customers or product.

TECHNICIAN AUDIT

Both initially and on an on-going basis, it should be confirmed that technical staff perform in accordance with any competence criteria and competence review carried out.

We provide a service to carry out what the industry calls Product Audits, to confirm technical staff are executing works in accordance with the company's and national standards. This may be used to further confirm the competence of an individual.
